4. First-Aid Measures

damage as well as reproductive disorders. Effects in humans, due to chronic overexposure, have included liver, cardiac abnormalities and nervous system damage. Contains carbon black. Chronic inflammation, lung fibrosis, and lung tumors have been observed in some rats experimentally exposed for long periods of time to excessive concentrations of carbon black and several insoluble fine dust particles. Tumors have not been observed in other animal species (i.e., mouse and hamster) under similar circumstances and study conditions. IARC lists Ethylbenzene as a possible human carcinogen (group 2B). Prolonged or repeated skin contact may cause dermatitis. May cause genetic defects.
